To the City Council of the City of Agawam, Massachusetts

EVERSOURCE requests permission to locate a line of poles, wires, cables and fixtures, including the necessary sustaining and protecting fixtures along and across the following public way:

SHOEMAKER LN

EVERSOURCE IS REQUESTING PERMISSION TO INSTALL (1) 45' CLASS 1 JOINT OWNED POLE TO INSTALL TRANSFORMER FOR CUSTOMER AT 501 SHOEMAKER LANE. THIS POLE WILL BE LOCATED APPROXIMATELY 25' FROM THE CENTERLINE OF SHOEMAKER LANE AND APPROXIMATELY 35' EAST OF EXISTING POLE 241/49. POLE TO BE LABELED 241/48M

Wherefore it prays that after due notice and hearing as provided by law, let it be granted a location for and permission to construct and maintain a line of poles, wires and cables, together with such sustaining and protecting fixtures as they may find necessary, said poles to be erected substantially in accordance with the plan filed herewith and made a part hereof marked 18136546

Also, for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as it may desire for distributing purposes.

Your petitioner agrees to reserve space for one crossarm at a suitable point on each of said poles for the fire, police, telephone and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.
